Instructions for Registration for MAH-LL.B-Yrs. -CET 2018:

- Aspiring candidates should download CET Information brochure from website <u>www.dhepune.gov.in/ and www.mahacet.org</u> for necessary details.
- 2. It is mandatory for all aspiring candidates to **Register & Confirm** the Online Application Form through candidate's login by himself/herself on the website.
- 3. It should be noted that no documents are required to be submitted at the stage of registration for CET. However, Candidates are advised to keep the necessary original documents ready for verification at the time of Document verification at the time of Admission, during Centralized Admission Process (CAP) in the Admitting College.
- 4. Applications sent by Post/Courier etc., will be rejected and no communication in this regard will be made.
- 5. MAH-LL.B-5 Yrs. -CET 2018 shall be conducted only in the ONLINE mode in multiple sessions if required by Competent Authority, using standardized equi-percentile method, will be equating scores across sessions.
- 6. Aspiring candidates should note that, the tests are not disclosed to anybody else other than the candidates only during the examination. The test papers are also not shared with anybody even after the Examination.
